I guarantee this Akita to the best of my knowledge to be of sound body, good health and free of any communicable disease at the time of sale/placement. Client has three working days from the date on this contract to take the Akita to the veterinarian of their choice. If at this time the veterinarian finds serious illness, it can be returned to Kiseki Akitas for a replacement or refund at the discretion of Kiseki Akitas.

As long as this Akita stays with the client and the prefix "Kiseki" is used on the AKC registration papers, this Akita will be guaranteed for five (5) years against any genetic disease that claims the life, causes serious handicap, or claims the sight (blindness) of the Akita. It must be the result of genetic origin and not the result of environmental factors (poor nutrition, accident, or illness) after the client has taken possession of this Akita.

Kiseki Akitas must receive written certification from an approved licensed veterinarian. The Client will then have the option of receiving a replacement Akita of equal value as soon as one is available. No other guarantee is made. No money will be refunded in whole or in part for any reason.

Client agrees to provide regular veterinary care, proper food, water, shelter and adequate companionship. \_\_\_\_\_ (initial)

Client agrees to notify Kiseki Akitas of any change of ownership or of change in address and/or telephone number. Client agrees to return Akita to Kiseki Akitas if Client is unable to keep Akita. \_\_\_\_\_ (initial)

Client understands when they purchase a companion Akita from Kiseki Akitas it is with the understanding that this Akita will be spayed/neutered by eight months of age and when Kiseki Akitas receives written certification that this Akita has been sterilized the client will then receive AKC registration papers. \_\_\_\_\_ (sign)

Client agrees to attend obedience class with this Akita within six months of the date of this contract. Client must understand that obedience class is necessary in teaching responsible dog ownership and proper socialization of the Akita itself. \_\_\_\_\_ (initial)

Client understands he/she is solely responsible for this Akita and to indemnify and hold harmless Kiseki Akitas from any and all claims of liability for the conduct of this Akita on or after the date of this contract. \_\_\_\_\_ (initial)

Violation of this contract damages the goodwill and reputation of Kiseki Akitas and the breed in general.  
Breach of this contract can result in repossession without reimbursement.

This contract is formed and shall be governed by the laws of the State of California, and jurisdiction to resolve disputes rests solely in a court of competent jurisdiction in California.
